

Groups & Events Rules

Please note the rules for Groups & Events applicable to all participants:

- 1. It is strictly forbidden to smoke inside the cottage. However, smoking is permitted outside the cottage (a penalty of \$1000 applies in the event of non-compliance with this rule). Please take care not to throw your cigarette butts on the site, pick them up before you leave and throw them in the trash.
- 2. For reasons of safety, respect for the neighborhood and the capacity of the septic and sanitary facilities, we require that the number of people appearing on the agreement be respected at all times by the renters. Additional guests are authorized during the day but the number of people who stay to sleep must comply with what is indicated on the agreement (strict supervision on site applies);
- 3. The Fiddler Lake Resort is a place where tranquility is essential. The use of RVs, ATVs, Skidoos, motorcycles and motocross is strictly prohibited. You can bring your motorcycles on a trailer to use them outside the domain (a penalty of \$500 applies in the event of non-compliance with this rule);
- 4. Fireworks, Bengal lights and flying Chinese lanterns are prohibited at all times on the estate due to the high risk of fire and/or noise pollution (a penalty of \$1,000 applies in the event of violation of this rule);
- 5. No exterior sound system is allowed outside the chalet after 10 p.m. (a penalty of \$500 applies in the event of non-compliance with this rule and complaint from the neighborhood);

- 6. Fiddler Lake is an ecological lake and motorboats are not permitted. To avoid contamination of blue-green algae from other lakes, any launching of a boat other than those provided is prohibited;
- 7. Open fires are strictly prohibited. Outdoor fires must be made in the fireplace provided for this purpose (a penalty of \$1,000 applies in the event of non-compliance with this rule);
- 8. The installation of tents and/or motorhomes or caravans on the estate is strictly prohibited:
- 9. We cannot be held responsible for any accident in the cottage, in the hot tub, the swimming pool, on the grounds and at the lake;
- 10. Any subletting is strictly prohibited;
- 11. The tranquility of the premises must be respected at all times. No excessive noise outside after 10 p.m. (including the pool, hot tub and sauna);
- 12. Do not move crockery, bedding, furniture or any other equipment between cottages without prior written permission from Chalets Zenya;
- 13. If you plan to install outdoor marquees tents, please let us know and we will indicate the location constraints in order to avoid irreparable damage to the septic fields;
- 14. Photos must be taken on the cottage grounds and at the main cottage (reception). It is forbidden to walk on the grounds of the other cottages of the estate, out of respect for the neighborhood.
- 15. Please respect the fauna and flora present on the grounds. Hunting is strictly prohibited as well as cutting the flowers on the grounds of the chalets to make bouquets.
- 16. Parking must be on the private spaces specific to each cottage, and not on neighboring lots. If you plan to park on the street, please let us know.
- 17. Do not use nails inside or outside for installation of equipment and/or decoration.

18. Your equipment suppliers must pick up the rented equipment before your departure.

Note that in case of non-compliance with these rules, we reserve the right to withhold the security deposit. By booking on our site or on any other partner platform, you are deemed to have read and agreed to comply with these regulations, as well as all the people accompanying you.
